Many people have asked me, "What is so enticing about a Communication and Technology Conference 5,000 miles away?" Well the answer is pretty simple. The Annual Eastern Region Conference is a powerhouse of a gathering of industry professionals, managers and enthusiasts.

For three days I was able to connect with field technicians, innovative producers, management aficionados, public policy and legal experts, and some of the most knowledgeable equipment representatives on the planet. The intriguing depth of conversation was impressive and imaginative. The workshops and special sessions are above par compared to other events of



this nature. Even more valuable was the opportunity to exchange ideas and practices with likeminded others during the all new Affinity Lunch. 12 distinct topics were fleshed out and shared among the participants and I am certain that many new opportunities were created as a result of sharing a lunch with a colleague.

The workshops are jam packed with useable information and hands on advice. I am not sure how the committee comes up with such an all-star list of panelists but they rival all other annual discussions. More impressive is the effort to stay a step ahead of the current trends while offering sage tips on best practices. I find it so refreshing to walk into a discussion thinking I know what I am talking about and leaving with the profound knowledge that there is so much more to learn. # Tech Talk: Did You Say Free ?!?!?

As post production professionals, it sometimes feels like everything and everyone is trying to get into your wallet. Everything seems to come with unexpected costs and it never seems to end. Sometimes you just make a poor purchasing decision and your investment you fought for just collects dust. Having a real world test of some new software or workflows you are integrating is the difference between a successful deployment or not. This month in the JAG Newsletter, we are going to look at some products that are free to use and learn. These softwares can help your workflow, solve a problem or just brush up your resume.

Nuke Studio by Foundry —Nuke Studio by Foundry is a single VFX, editing and finishing application. It is also a node-based compositing software. It differs from other compositing software like Adobe After Effects as Nuke Studio has the option to have you work node-based and not layer based. What that offers is a compositing workflow that has a feel more like a flow chart than working with layers. People who work in node-based softwares become evangelists of them quickly because it allows your workspace to be much more visual and you can find any aspect of your work quickly as opposed to digging through layers. Not ready for such a workflow change? Worry not, because Nuke Studio can have its user interface toggled to a more traditional editing workflow.

What else is Nuke? It's a visual effects software and not a motion graphics editor like After Effects. It is not a product that can just jazz up video that you have. It can help you create things that seem visually impossible. Last year, it was used in countless films, TV shows and commercials all over the globe. They have their NAB show reel on their website ad its dazzling, quite impressive and worth watching. Nuke Studio achieves all this by allowing users to work the software in different modes. Modes such as Conforming, Editing, Reviewing, Compositing and more. All of these modes are just tabs in the software's user interface. That means if you a video editor who is trying to ramp up on compositing, you just need to click a tab to see how your editing work translates into compositing and also to try your hand at composting.

What's the catch? Well there is a full paid version of Nuke Studio and with that paid version you get resolutions higher than HD such as 4K. You also cannot share projects between the free and commercial versions. There are a handful of other features disabled and you can check Foundry's website for more info, but the list of what is disabled is small. With what you are given, you can create projects end-to-end without watermarking. So why would Foundry hand out copies of their top-of-the-line flagship product? Because they are very motivated to get people comfortable with learning their software. It will take just about any exiting project from most major post production software companies, so you can import your existing projects and see how they perform. For the asking price, why not give it a try? The even also free tutorial on their website to help you get your feet wet.

DaVinci Resolve LIte —Does your non-linear editing software of choice underwhelm you with its color correction and color grading offerings? Have you ever dreamed of getting better at being a colorist, but afraid that you can't because you don't have the budget for a fancy control surface with trackballs? Of pehaps you have heard of DaVinici Resolve and assumed you needed one of those fancy control surfaces to use it? BlackMagic offers a free version of one of their industry standard products, DaVinci Resolve. Most important, you don't need any supplemental control surface hardware.

Using DaVinci Resolve is a breeze. You can edit in it natively, or you can import your timeline from your non-linear editing software of choice. Its preferred media formats are ProRez and DNxHD. Like Nuke, it is also a node-based compositing software.

The Resolve user interface may seem intimidating at first, but it's layout is broken down into 4 categories at the bottom of the user interface, Media, Edit, Color and Deliver. Each part should be familiar with anyone who edits, as you need to do each of them for each edit you do. Like Nuke Studio, the editing user interface is familiar enough that anyone who has edited before will feel right at home. The section that really makes Resolve special is the Color tab.

The Color tab is what makes Resolve special. You have color controls, motion tracking, color matching, full scopes, secondary correction, the list goes on and on. The color tab is so feature-rich that the best way to describe it is that has every color correction tool you have ever seen all in one software. It is also easy to pick up as well because there is a cornucopia of free training videos on Youtube.

Most people have heard of DaVinci Resolve and it has a bit of prestige with its name. So you may ask, "What aren't I getting in the free version that I would get in the paid version?" The answer is you limited to HD resolutions, no support for certain graphics cards, no control surface support, no support for multiple processors and no shared projects using a database server. If you upgrade to the full version, you can really take advantage of supplemental computer hardware to speed up your rendering and processing of files.
